Jillian maintains an active interest in the arts, having been on the Board of the Sydney Theatre Company, a founding director of the Australian Brandenburg Orchestra and a Trustee, Vice President and Treasurer of the Art Gallery of New South Wales. Jillian was President of Chief Executive Women, a group of professional women leaders for 2005 and 2006. She was Chairman of the National Institute of Dramatic Art (NIDA) from 2005 to 2007.

She graduated from the University of Sydney with a Bachelor of Arts, majoring in economics and maths.

Jillian was made an Officer in the Order of Australia in 2003. She has an Honorary Doctorate Degree from the University of Western Sydney and was awarded the Qantas/Bulletin Businesswoman of the year in 1987. She was a recipient of the Australian Centenary Medal in 2001 in recognition for her contribution to the community.
