Before joining the Grattan Institute, Saul Eslake was the Chief Economist of the Australia & New Zealand Banking Group (ANZ). He was a member of ANZ's Group Asset and Liability Committee, which oversees the management of the Bank's balance sheet, and is also Chairman of ANZCover, the Bank's internal fraud, crime and professional indemnity insurer.

Prior to joining ANZ, he was Chief Economist (International) at National Mutual Funds Management (now part of the AXA Insurance group) and Chief Economist of the stock broking firm McIntosh Securities (Merrill Lynch group) from 1986 to 1991.

Saul has been member of three Federal Government advisory panels in recent years - the Tourism Forecasting Committee, the Trade Policy Advisory Council, and the Foreign Affairs Council. As an expatriate Tasmanian Saul also maintains links with his home State, as a Board Member of the University of Tasmania Foundation, and Chairman of the Tasmanian Arts Advisory Board.
