Bob holds a Bachelor of Science degree and a Doctorate of Philosophy (Metallurgy) from the University of New South Wales and is a Fellow of the Australian Academy of Technological Sciences and Engineering. Other listed companies of which he is or has been a director in the last three years are Chairman of Iluka Resources Limited (appointed March 2004), and Sims Group Limited (appointed October 2005 - resigned November 2007).

Bob is also a director of O'Connell Street Associates Pty Limited, OCA Services Pty Ltd and the Malcolm Sargent Cancer Fund for Children in Australia Limited, known as Redkite. He was also the Chairman of the New Zealand-based listed company Steel & Tube Holdings Limited and a director of OneSteel Limited. Other positions previously held by Bob include Managing Director of Tubemakers of Australia Limited, President of BHP Steel and Managing Director and Chief Executive Officer of OneSteel Limited, a position from which he retired in May 2005. He was also a director of CARE Australia.
