David is Chairman of Investec Bank (Australia) Limited, an investment and advisory bank in Australia. Investec acquired David's corporate advisory firm Wentworth Associates Pty Limited which he established after leaving Freehills where he was a partner.

David is Chairman of Coca-Cola Amatil Limited and ASX, the Australian Stock Exchange, a Director of the Westfield Group, Singapore Airlines and the ASX Limited. David is also Chancellor of the University of New South Wales, Chairman of the UNSW Foundation and Chairman of Sydney Grammar School. He was previously a member of the Takeovers Panel, President of the Board of Trustees of the Art Gallery of New South Wales, Director of ANZ Bank Ltd and Chairman of the Australian Council of Arts.

Born in 1953 in Cape Town, South Africa, David Gonski migrated to Australia with his family at the age of seven. He was appointed to the Order of Australia as an Officer (AO) in 2002 for services to the community which was elevated to a Companion of the Order of Australia (AC) last year, and received the Centenary Medal in 2003
