Prof Fred Hilmer AO is the President and Vice-Chancellor of the University of New South Wales, an appointment he began in June, 2006. He also serves as a director and Leader Independent Director of the Westfield Group.

Fred Hilmer was Chief Executive Officer of John Fairfax Holdings Limited from 1998-2005. Prior to this appointment he was Dean and Director of the Australian Graduate School of Management (AGSM) at the University of New South Wales and he was also a Director at McKinsey and Co, responsible for Australian practice. Fred holds a degree in law from the University of Sydney, an LLM from the University of Pennsylvania, and a Master of Business Administration degree from the Wharton School of Finance where he was appointed a Joseph Wharton Fellow.

In 1992 he chaired the National Competition Policy Inquiry which led to major micro-economic reforms. Fred Hilmer was appointed an Officer of the Order of Australia in 1998 for his service to management education, competition policy, and workplace reform, and has been awarded a special John Story Medal by the Australian Institute of Management for his contribution to management thinking.

Prof Hilmer has also held a number of other senior business positions including Chairman of Pacific Power, Deputy Chairman of Foster's Group Limited and a Director of a number of other Australian companies.
