John Mullen was also a member of the Board of Management of Deutsche Post World Net, the parent company of DHL. DPWN is the world's largest transportation and logistics group by revenue, with annual sales of over EUR 50 billion and some 500,000 employees.

John Mullen is well regarded as a senior industry veteran. Prior to his current role, he was Chief Executive Officer for DHL Express' operations in Asia Pacific. His experience includes ten years with the TNT Group, with two years as its Chief Operating Officer. From 1991 to 1994, he held the position of Chief Executive Officer of TNT Express Worldwide, based in the Netherlands.

John's current and past directorships include Telstra, Embarq Corporation in the US, the Economic Development Board of Singapore, Transportes Guipuzcoana of Spain, Ducros (France), Securicor Omega Holdings (U.K), the Advisory Council of the City of Seoul (South Korea), and the International Swimming Hall of Fame in the US.
