Dr Ziggy Switkowski is a former CEO of Telstra, Optus and Kodak (Australasia). He is currently a non-executive director of Suncorp, Tabcorp, Healthscope and Opera Australia. In 2006, he chaired the Prime Minister’s Review of Uranium Mining, Processing and Nuclear Energy, and more recently has been appointed to the Chair of the Australian Nuclear Science and Technology Organization. Dr Switkowski is a graduate of the University of Melbourne with a PhD in nuclear physics. He is a Fellow of the Academy of Technological Sciences and Engineering.

Dr Switkowski will address members and guests on the topic “*Climate Change & Nuclear Power in Australia*”. The world is experiencing a strong warming trend believed to be driven by greenhouse gas emissions associated with the burning of fossil fuels for energy production. Australians’ demand for electricity, and energy in general, is expected to double by 2050. The challenge is to moderate and meet this growing demand in an environmentally responsible way. Nuclear power is already widely used around the world and the debate for its deployment in Australia is well underway. This presentation will review the nuclear fuel cycle in the context of low emission energy technology and point to the potential role of nuclear power in Australia’s energy and climate change strategy.
