In 1999, he was re-elected to the executive board and from 2001 to 2003 served as chairman of the Chamber. In 2001, he was awarded the Cross of Merit of the Federal Republic of Germany.

Mr Wilde will address members on the structure and operations of TÜV Rheinland and the recently established Melbourne office of the Group.
